1. Adoption of the minutes and of the agenda

1.1 Minutes of the 24th EDPB meeting – adoption

The minutes were adopted with the suggested changes.

1.2 Draft agenda of the 25th EDPB meeting – adoption

The draft agenda was revised in order to include points 3.1 and 3.2 under the Any Other Business. The revised agenda was adopted.

2. Current Focus of the EDPB Members

2.1 EDPB letter on Polish presidential elections via postal vote – discussion and adoption (Rapporteur: Chair)

The Chair explained the background of the letter. Several citizen e-mails were received on this issue and also two MEPs sent a letter to the EDPB about it. The Secretariat provided the background information regarding the situation in Poland and presented the key messages of the letter.

Polish SA presented the latest developments in this issue and expressed its concerns regarding the procedural approach.

The EDPS also explained its position and the content of its response letter to the MEP. Several complaints were also sent to the EDPS on this regard, although some of them were found inadmissible due to lack of competence of the EDPS to deal with them.

The members of the EDPB discussed the content of the letter. In this regard, considering that important decisions will be taken tomorrow in Poland about the election, the EDPB members decided that some parts of the letter will be finalised at the next meeting of the CEH ESG taking place on 7 May. The letter will be discussed again in the view of its adoption at the next plenary meeting on 8 May 2020.

2.2 Possible public consultation on revised Guidelines on consent under Regulation 2016/679 – discussion (Rapporteur:

The members of the EDPB discussed the possibility of having a public consultation for the update of the guidelines, taking into account that the Guidelines were already subject to a public consultation in the past.

The members of the EDPB decided to vote regarding the public consultation. 15 EU members and 3 EEA members voted against it. 9 EU members voted in favour of it (2 stated that this should be targeted to the changes made). 1 member abstained.
